



# Colorado Children's Health Insurance Status

## County-Level Estimates of Children Eligible For But Not Enrolled In Medicaid or CHP+

Colorado has taken steps in recent years to reduce the number of uninsured children.

Eligibility for public insurance has been expanded, and the so-called "stair step," which sometimes meant that children in the same family were eligible for different public programs, has been eliminated. The hope is that by having one eligibility level for all children, regardless of age, the enrollment and renewal process will be simpler and will lead to more children being insured.

This data supplement contains the Colorado Health Institute's estimates of uninsured children who are eligible

for but not enrolled (EBNE) in the Medicaid and Child Health Plan *Plus* (CHP+) public insurance programs. An estimated 8.9 percent of all Colorado children were uninsured in 2012 (see Table 1). Of the uninsured children, approximately 81,600 had family incomes at or below 265 percent of the federal poverty level (FPL), making them eligible for Medicaid or CHP+.

### DATA SOURCES

**The U.S. Census Bureau's 2012 American Community Survey (ACS).** The ACS is an annual stratified random sample survey of approximately 51,000 Coloradans. These estimates include only uninsured children who were either U.S. citizens or were legal residents who had lived in the country for at least five years and met the income eligibility guidelines. A child was counted as uninsured if his or her parent reported that the child did not have any form of health insurance at the time the ACS questionnaire was administered.

**The Colorado Department of Health Care Policy and Financing (HCPF) Budget Division** provided county and state Medicaid and CHP+ enrollment figures. These enrollment figures summarize the average monthly enrollment between January and December 2012.

# Changes in Methodology: Comparing Estimates to Previous Years

Two important policy changes implemented since these data were collected are likely to impact EBNE estimates in the next few years. First, in 2013 Colorado eliminated the so-called “stair step” in Medicaid that often resulted in children in the same family qualifying for different insurance. Now, all children must meet the same family income criteria for both Medicaid and CHP+, regardless of age. This change results in more Colorado children being eligible for Medicaid. Not surprisingly, it also means that fewer children are eligible for CHP+.

Second, a new method of determining net income effective in 2014 – called Modified Adjusted Gross Income or MAGI – has changed Colorado income eligibility levels. The MAGI eligibility standards for children used in this analysis are:

- **Medicaid:** Up to and including 147 percent of FPL
- **CHP+:** Between 148 percent and 265 percent of FPL

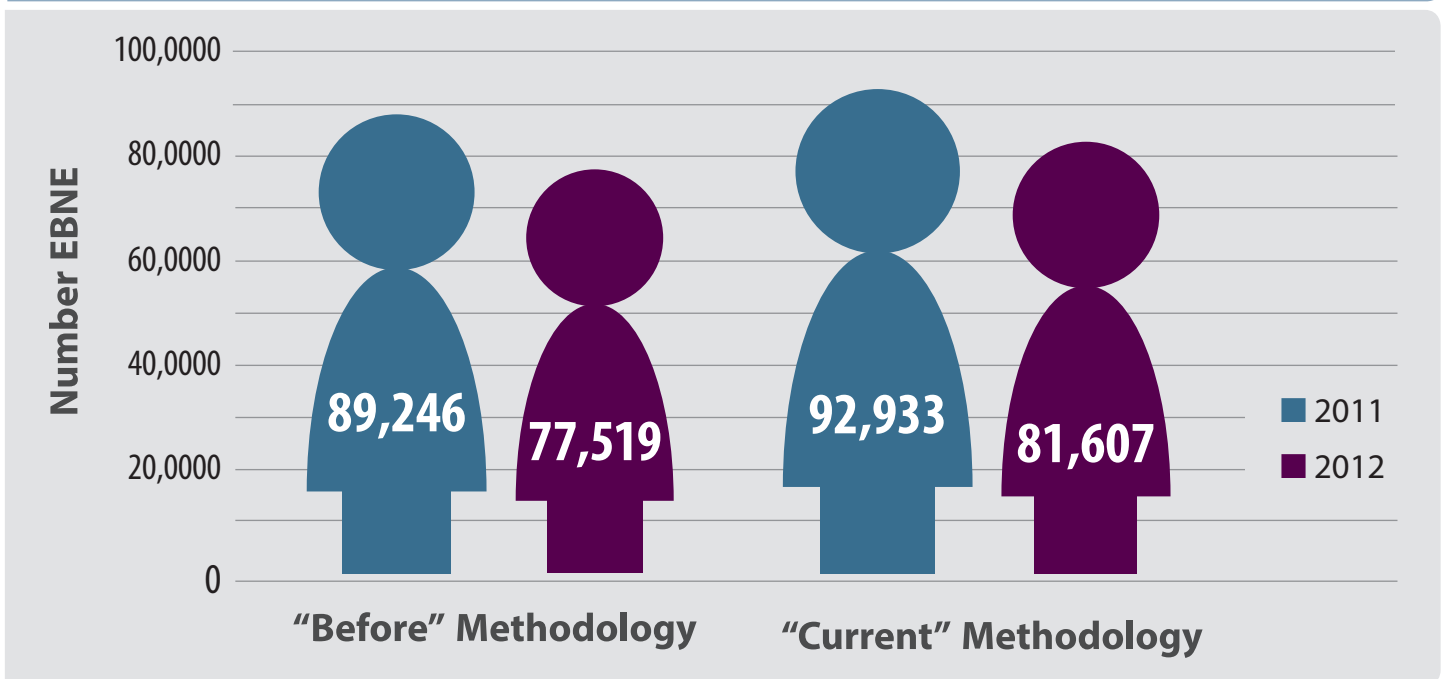
In order to control for the future impact of these changes, the Colorado Health Institute modeled the number of children eligible but not enrolled in 2011 and 2012, assuming that these policy changes were in place. This allows us to estimate

how many children are currently eligible and to set a baseline to compare to future estimates. In other words, when CHI estimates the number of EBNE children a year from now, those estimates will be directly comparable to the estimates included in our “current” methodology. This will let us measure the impacts of outreach and enrollment activities as opposed to one-time effects due to policy changes regarding eligibility requirements.

Because of these changes, the latest EBNE data are not directly comparable with findings from previous years. They do, however, serve as critical baseline information to help measure the impact of the Affordable Care Act and other federal and state reforms on insurance coverage in Colorado.

At the same time, it is instructive to do a comparison of the data under each scenario – before and after the stair step and MAGI changes – to understand how these policy decisions are influencing coverage among Colorado’s lowest-income children. To do this, the Colorado Health Institute calculated and compared the 2011 and 2012 data using both the previous method – “before” and the new method – “current.”
