# HEALTH IN COLORADO

- Obesity: 1/5 adults and 1/6 kids
- Mental Health: 1/6 say mental health is not good
- Uninsured: 1/5 adults and 1/10 kids
- Vaccines: Almost 1/3 preschool-age kids lack recommended vaccines
- Medicaid: Over 650,000 receiving coverage
- Health Industry: Over 250,000 workers with \$11.3B annual payroll

  - Hospital Provider Fee
  - Medicaid Expansions for additional 100,000
- All Payer Claims Database (HB10-1330)
  - Colorado Health Benefit Exchange (SB11-200)
- Medicaid Payment Reform (HB12-1281)
- Federal
  - HIPAA/HITECH (2/2009)
    - EHRs & Meaningful Use
    - Health Information Exchange (CORHIO)
  - Patient Protection & Affordable Care Act (3/2010)

### COLORADO & HEALTH REFORM

#### Better Coverage

- Insurance coverage for additional 45,000
- Lifetime limits eliminated for 2 million
- Better Care
  - Preventive care added for almost 1.4 million
  - Enhanced payments for community providers
- Lower Costs
  - Prescription drug costs cut for 40,000 on Medicare
  - 2011 insurance company rebates for 121,000
  - 2014: Tax credits in the Exchange for over 500,000
- Leveraging Federal & State Funds

  - DOI: Protecting consumers through rate review
- Medicaid
  - Accountable Care Collaborative
