As a community leader you likely know how your community is thinking and feeling about COVID-19. You may know your community is at increased risk because they are working in grocery stores, working in

long term care facilities, or they have higher rates of heart disease or diabetes. Maybe some people in the community feel the COVID-19 focus is overblown, or that they are not at risk. Or perhaps they are very fearful that this represents yet another way they will be marginalized and bear greater burdens of disease or negative aftereffects from COVID-19. Whatever the circumstances, you know your community. This document is intended to support you in getting the COVID testing support your community needs.

First thing to know, any CBO or community partner, for example a local fire station, place of worship,

business, non-profit organization, etc. can request testing resources for their community, using the community test site and resource request. Someone from the CDPHE lab will contact you within 1-5 days of submission. To request staff who can take samples, please use the link here. Some communities that are at higher risk of disease or severe illness will be prioritized for free testing and testing support, e.g., testing supplies, staff to perform the tests. Each county has a target number of tests to perform each day. Below is a table showing some of those targets and testing rates at the time this document was prepared. A link to updated data is also provided in the footnote below.

Unfortunately, some medical conditions put people at higher risk for the disease, including lung disease, heart disease, immunocompromised status, severe obesity, diabetes, chronic kidney disease, liver disease or tobacco use. You can find data for your county on these conditions at the <u>Center for Improving Value in Health Care</u>. You can also look to see if there are any <u>public health outbreaks</u> in your area.

If you decide your community needs testing resources, follow these steps:

- **1.** Understand the overall flow of information from testing to patient notification using this <u>link</u>.
- 2. Request needed staff to take samples.
- **3.** Request any other needed resources through the community test site and resource request link.
- **4.** Walk through the testing event worksheet, and marketing and outreach planner worksheet below.
- **5.** Encourage community members to record their symptoms in the state's <u>symptom tracker</u>. After entering their information, people are directed to 211 resources and get supportive text messages. It also helps the state decide where to locate testing resources.
