What is PopMedNet?





- Open source distributed ("Federated") data sharing network for institutions that want to share information and analytics but not the underlying data
- Investigators submit queries through a web browser
- Developed by software development company, Lincoln Peak
- On behalf of the Department of Population Medicine at Harvard Pilgrim Health Care Institute
- For Mini-Sentinel project
- Now adopted by multiple national initiatives

PopMedNet Principles*


- Send the questions to the data
- Keep data in the hands of the original data holders
 - Decrease proprietary and liability issues
 - Decrease risk and severity of breaches
 - Data holders know their data; improve value and interpretation of findings
- Minimize data transfer
- Voluntary data partner autonomy
- Reciprocity value for participation
- Partnership
- Well-defined purpose

PopMedNet's Distinguishing Strengths

- No co-mingling of data from different institutions
- Powerful rights management
- Human review included in workflow
- Data-source agnostic
- Uses "pull" architecture, so relatively easy to implement at data partners



What is CHORDS?



- Colorado Health Observations Regional Data Service
- A collaboration between several Colorado research and health care organizations
- Technical and policy infrastructure to support regional data sharing for research, patient care, and surveillance
- Early projects have focused on public health
 - Tobacco use and exposure
 - Obesity
 - Cardiovascular risk

How did CHORDS Choose PopMedNet?

Developed project-specific use cases, which we then generalized into high-level use cases.


- Created requirements based on the high-level use cases
- Identified four candidate platforms and assessed their ability to satisfy the requirements


PMN's High-Level Architecture







CHORDS Status: Governance

- Governance is a critical component of any data sharing network.
- CHORDS has a draft governance document, based on work by national groups.
- Such documents should address organizational structure, data management, security / privacy / confidentiality, and resource allocation

CHORDS Status: Technical

- Twelve partner sites
- All have installed the data mart client and run tests.
- Two adaptors delivered. Three more under way.
- DataMart deployment is simple and quick.
- Manuals written for administrators, developers, and investigators.
- Using version 5.

Changes in Version 5

- Can update plug-ins without installing a new version of the DataMart Client
- Security is simplified, improving performance
- Documents are stored encrypted on the file system (vs. within the database)
- REST API instead of MVC design pattern provides future development flexibility

Steps Needed to Implement PMN for CCRN

- Set up a CCRN instance of PopMedNet Query Portal
 - Separate instance provides independence on when CCRN moves to a new version of PMN
 - Would be built off of our modified code base
- Build plug-ins for CCRN data needs
 - Cost depends on complexity of plug-in
 - We will participate in discussions re plug-in requirements
- Configure Query Portal for CCRN
 - Data partner organizations and users
 - Logos, website, etc.
- Deploy PMN DataMart Client at Data Partners
