Note that the American Community Survey contains variables on citizenship but not on whether a person has legal documentation status. CHI developed a method for estimating documentation status based on a Pew Hispanic Center report describing the characteristics of the undocumented immigrant population in the U.S. CHI created a logistic regression model of the likelihood that a noncitizen was an undocumented immigrant based on these characteristics. For example, Pew's report estimated that 49 percent of undocumented immigrants in the United States are adult men, compared with 44 percent of non-citizens who have legal documentation. Therefore, CHI estimated a non-citizen was 12.5 percent more likely to lack legal documentation if he is an adult male — the difference between 49 percent and 44 percent. The full model was based on age, sex, employment status, and country of origin. Because individual-level data were required to build this model, estimates were developed using the IPUMS public use microdata area files. Census tract estimates were developed by crosswalking these microdata areas using a methodology developed by the University of Missouri.
