CHAS: The Questions It Answers





CHAS: The Basics

Insurance: How many people are uninsured and why do they lack coverage?

Access: Who has trouble getting an appointment, even with insurance?

Use of Care: Where do Coloradans get their health care? How often do they use that care?

Affordability: Do people go without care due to cost? What are people willing to pay for insurance?

Health Status: How do Coloradans rate their physical, mental and oral health?





How It's Fielded



Who: 10,224 randomly selected households

What: Twenty-minute telephone survey

When: Between April 15 and July 27, 2013

Where: Statewide, divided among 21 Health Statistics Regions

Why: To gather information that can inform policy-making and help measure health reform efforts

- Sets a baseline for health reform
- Trends three years of data
- Adds questions
- Makes data

more accessible




2013 Children's Uninsured Rate







Children's Uninsured Rates by Income



Eligible But Not Enrolled Children (EBNE)


Number of Uninsured Low-Income Children (ages 0-18) in Colorado Eligible But Not Enrolled in Medicaid and CHP+ 2008-2011








Children's Uninsured Rates by HSR






Children's Uninsured Rates by Race/Ethnicity








Children's Uninsured Rates by Citizenship

Reasons Why Children Are Uninsured

	2009	2011	2013
The person in family who had health insurance lost job or changed employers*	27.4%	50.1%	31.8%
Family member's employer does not offer coverage or not eligible for employer's coverage**	39.2%	42.9%	25.9%
Cost is too high	83.2%	76.5%	82.3%
Don't need insurance	3.4%	10.7%	24.0%

*Refers to family member who had health insurance.

**Refers to family member's employer



Children's Health Insurance Coverage



Churning Among Children




- Insured all of prior 12 months (same coverage)




Mixed Coverage Families

Barriers to Care for Children

Among Uninsured Children...

You couldn't	2013
Get an appointment because the doctor's office wasn't accepting patients with your type of health insurance	5.8%
Get an appointment because the doctor's office wasn't accepting new patients	7.3%
Find transportation to the doctor's office/ it was too far away	4.6%
Take off from work (asked of employed*)	5.6%

* CHAS places adults as well as children with working parents in this category


28.1% didn't seek an appointment because they were uninsured.
